Winter Haven Tax Planner Earns Certified Tax Coach™ Designation

Winter Haven, FL – Lynn A. Schmidt, EA announced today that she is now a member of an elite group of professionals who has completed the American Institute for Certified Tax Coaches' training program leading to the Certified Tax Coach™ designation. Lynn is one of only six Certified Tax Coaches in the State of Florida and the only Certified Tax Coach in Polk County.



“Taxpayers who really want to beat the IRS can’t wait for their accountant to work magic with a stack of receipts on April 15,” says Schmidt “They need a plan for taking advantage of every deduction, credit, loophole, and strategy allowed.”

“Traditional tax professionals focus on putting the right numbers in the right boxes on the right forms,” says Dominique Molina, a San Diego-based CPA and Director of the American Institute of Certified Tax Coaches. Schmidt says “Our program is different,” “We don’t just help our client’s record history. We help them write it, with a complete menu of advanced tax-planning concepts and strategies.” Schmidt goes on to say “good tax planning does not just happen by accident”.

The Certified Tax Coach™ program focuses on court-tested, IRS-approved strategies for minimizing Alternative Minimum Tax, maximizing deductions from real estate and passive activities, maximizing retirement savings, and similarly powerful strategies. As taxes rise to cover increased government spending, this sort of proactive planning will become even more important in the future.

To earn the designation, Schmidt completed an intense three-day training program. She has also agreed to abide by the AICTC Code of Ethics and complete 24 hours of tax-planning continuing education each year. Schmidt is also an Enrolled Agent, a federally licensed tax professional who has demonstrated technical competence in tax law. EA’s are the only taxpayer representatives licensed to practice by the United States Government. Most people think that tax season ends with April 15th; Schmidt contends that April 16th is actually the beginning of a “New Year” for tax planning and adding the Certified Tax Coach designation to the Enrolled Agent designation strengthens the tax planning skills that Schmidt has at her disposal to empower her clients to pay the “lowest, legal tax bill possible”.
